DECLARATION OF MICHAEL E. SODERBERG

I, Michael E. Soderberg, declare as follows:


1. I have personal knowledge of the facts set forth in this Declaration. If called as a witness, I could and would testify competently to such facts under oath.

2. I am the Chief of Detectives of the Los Angeles County Sheriff's Department (the "Department"), in charge of all major criminal investigations within the jurisdiction of the Department. Barbra Streisand resides within the jurisdiction of the Department. I have 33 years of experience with the Department.

3. In my experience, it is far more likely that a public figure will be the victim of stalking incidents including threats of violence to them and their families than others. The Department responds to such incidents on a regular and ongoing basis.

4. As Chief of Detectives of the Department, I am aware of several occasions where Barbra Streisand was the reported victim or target of such incidents. The Department has responded to these incidents which occurred at her residence.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct, and that this Declaration was executed on the 2nd of July 2003, at Santa Monica, California.
