1 Plaintiff Barbra Streisand's motion for preliminary injunction having come on regularly  
2 for hearing on July 14, 2003, in Department H, the court having considered all of the papers filed  
3 by Plaintiff and Defendant Kenneth Adelman in support of and in opposition to the motion for  
4 preliminary injunction, the matter having been submitted, and good cause having been shown by  
5 Plaintiff for the issuance of a preliminary injunction, the court grants Plaintiff's motion for  
6 preliminary injunction.

7 Therefore, be it ordered that Defendant Kenneth Adelman is hereby enjoined and  
8 restrained from:

9 (a) displaying the name of "Barbra Streisand" in any shape or form on the website  
10 bearing the address www.californiacoastline.org (the "Website") owned by Adelman to identify  
11 any location, property, home, plot of land, residence, or any other demarked piece of real estate,  
12 whose photographs appear on the Website;

13 (b) identifying any location, property, home, plot of land, residence, or any other  
14 demarked piece of real estate, whose photographs appear on the Website as being in any way  
15 associated with Streisand;

16 (c) using Streisand's name or any other form of identification associated with  
17 Streisand to sell any photograph of any location, property, home, plot of land, residence, or any  
18 other demarked piece of real estate, whose photographs appear on the Website.

19 This order is effective immediately.

20 Formal preliminary injunction order and bond in the amount of \$1,000 are to be filed in  
21 Department H no later than \_\_\_\_\_.
